THE NOTICE MUST SAY THAT YOU DO NOT WISH TO BE BOUND BY THIS AGREEMENT AND FAXED TO STEWARDSHIP MASTERS INTERNATIONAL, INC TO RECEIVE A HUNDRED (100%) PERCENT OF YOUR PAID MEMBERSHIP FEE. AFTER YOU SIGN THIS AGREEMENT, THE DOCUMENT MUST BE DELIVERED OR POST MARKED BEFORE MIDNIGHT OF THE THIRD BUSINESS DAY, TO Stewardship Masters International, 200-19 Linden Blvd, St. Albans, NY 11412.**
